

## "C.A. Osasuna Retro Shirt Giveaway"

C.A. Osasuna, with Tax ID No. G31080179 and registered office at C/ Sadar, S/n, C.P. 31006 – Pamplona, Navarra (hereinafter "OSASUNA"), is organizing a promotion called "C.A. Osasuna Retro Shirt" from April 17, 2026 to April 30, 2026, for the purpose of promoting its products and services.

Accordingly, OSASUNA will carry out a free random draw for advertising purposes (hereinafter, the "giveaway") under the terms and conditions set out below.

### **TERMS AND CONDITIONS**

#### **1. DURATION, DRAW DATE, AND TERRITORIAL SCOPE**

Participants may enter from April 17, 2026, until April 30, 2026, at 12:00 p.m.

The winner will be selected on April 30, 2026, at 1:00 p.m., in a fully random and automated manner. The winner will be notified immediately afterward.

The territorial scope of the giveaway is Spain. Participation is free of charge.

#### **2. PARTICIPATION (ENTRY REQUIREMENTS)**

Participation is open to individuals of legal age residing in Spain who register via OSASUNA's official app.

##### **How to participate:**

i) Be registered in the Osasuna App and access the giveaway.

Participation is limited to one entry per user. Participation implies full acceptance of these terms.

Automated participation systems are prohibited. Invalid or late entries will be excluded.

### **3. EXCLUSIONS**

Those who do not comply with any of the requirements established in these terms for access to the promotion may not participate, with OSASUNA having the right to exclude from the giveaway those who do not meet the access requirements.

The following are excluded from participation in the giveaway: minors, Spanish nationals who are not residents in Spain, and foreigners who do not have a Spanish residence card. Employees of OSASUNA may not participate either.
